



**The Arts Institute - Theatre Institute (IDU) in cooperation with the Inkonst Malmö, Czech Centres/Czech Centre Stockholm and the Ministry of Culture of the Czech Republic announces a call for applications for a three-week creative residency in the field of music and artists working in the borderland between art, sound art and experimental club culture, which will take place between October and December 2024 at the Inkonst art centre in Malmö, Sweden.**

The creative residency is intended primarily for young artists of Czech citizenship or permanent residence in the Czech Republic. It is not intended for high school and university students. The host organization is the art centre Inkonst in Malmö, Sweden and the coordinator of the residency is the Czech Center Stockholm.

### **About the Residency:**

The creative residency will take place at art centre Inkonst in Malmö, Sweden, that has a fully recording studio equipped with a Genelec listening system and Erica Synths modular system that will be available to the artist 24/7 and a technician upon previous request. **Full studio specs here.** The artist will be accommodated in a serviced apartment in the same block as Inkonst and the studio. This is in the heart of Malmö, the third biggest city in Sweden with all the amenities being within walking distance.

### **Participant profile**

- Czech citizenship or permanent residence in the Czech Republic
- English language at a level enabling full completion of the residency, German is an advantage
- Emerging or established artist working in the borderland between music, sound art and experimental club culture

### **Residence characteristics**

- Creative residency in field of electronic music, sound art and experimental club culture
- Duration: 3 weeks (21 days) within the 1<sup>st</sup> of October and 15<sup>th</sup> of December
- Location: Inkonst, Malmö, Sweden
- The participant will receive a residency allowance of 60 EUR / each day of residency (without traveling days) + up to 300 EUR for travel expenses
- Fully covered accommodation in a serviced apartment few minutes from the art centre
- Expected outcome: Upon discussion with the art centre music director

### **Terms and conditions**

- Applications submitted after the deadline, incomplete or incorrect projects will not be included in the selection procedure.



- Submitted applications will be evaluated and selected by an international expert committee (local curator, IDU representative, and the Czech Centres/Czech Centre Stockholm).
- The selected participant will send a written report on the residency and the realisation of his/her artistic project in a minimum of one A4 size no later than 14 days after the end of the residency.
- The support will be granted based on a commissioning contract concluded with IDU and will be paid after the realisation of the event based on the delivery of the final report or the fulfilment of other contractual conditions. The amount of support will be paid without VAT (VAT will be paid by the applicant, if applicable).
- The call is launched within the framework of the project 'IDU programmes to support mobility and trade missions abroad of professionals from the CCI sector'.
- The supported participant will include the obligatory logos in all electronic (or printed) promotional material for the residency: National Recovery Plan, Next Generation EU, Ministry of Culture of the Czech Republic, IDU, Czech Centres, as well as the statement "Funded by the European Union - Next Generation EU".
- The organisers reserve the right not to carry out the residency.
